

Citations Module

Designed for **Traffic, Criminal, Parking** and **Warning** Citations, this Police Central Module collects and manages the **complete process**. Complete biographical, location, vehicle, charge and adjudication information is stored in the fully searchable database. Any number of Citations may be entered for a single event. **Fines** and **Payments** can be **manually entered**, or **automatically calculated**. Police Central will add special charges for DUI Charges or other special fines and fees, including Victim Assistance Fees as determined by State and Local ordinances. **DUI Test results** are tracked if applicable. If fines are paid on a **Payment Schedule**, the Citations Module provides a full audit log of payments, dates and times. All fields are **fully searchable** and inquiries to the database are easy and fast. The system interfaces with other Police Central Modules, including Criminal Warrants, Civil Process and other integrated Modules.

Personal, Vehicle & Violation Information

Complete **biographical information** from the Citation is entered pertaining to the Person, Vehicle, and Violation. Information is automatically stored in the exclusive **Police Central Jacket**, and checks for complete history, including Warrants and Civil Papers. Jacket maintains complete personal history. Drop-Down List simplifies keyboard entry. **Any number of Citations** may be added to the individual at a single typing.

Fines & Fees

The Police Central Citations Module can be configured to **automatically calculate fees**, adjustments and payments based upon Local statutes and codes. System totals and displays the Total Amount Due, permits adjustments by the Judge, including Fines, payment schedule and Jail Time. Prints Receipts, and tracks payments, for accurate history.

Court Docket

Will prepare the Court Docket that can be emailed to the Judge as well as Involved Officers.

Integration with Other Police Central Modules

All Police Central Modules are fully inter-related. Citations are stored in the persons Police Central Jacket that maintains a complete personal history. All information is available to the Criminal Warrants Module for preparation of a Bench Warrant, if necessary. And, if an arrest is made, full current information is available for the Booking Process. Police Central's exclusive Investigator's View discloses all current and historical information to authorized personnel for investigative purposes.

Queries and Printed Reports

Police Central will print all state-mandated forms and reports, including DUI documentation. The system is fully searchable, so inquiries from drivers are quickly processed. Powerful queries, combined with the powerful Police Central Administrative Reports can provide recap information easily.
