

Civil Process Module

The Police Central Civil Process Module fully automates all **civil papers** and **service** procedures. **Papers are entered** as received, tracking **Complainant** along with a single or multiple **Defendants** and **Case Type**. For **multiple defendants**, each service is tracked individually. The Module can track service attempts, mileage, associated fees and costs, as well as information that may be required by your local agency. Full Administrative Reporting provides **management information** to the executive staff. Automatically maintains a full **history**, including Liens, Garnishment, Restraining Orders and other papers. System utilizes the Police Central Jacket and checks to see if persons are **currently incarcerated** or have **Outstanding Warrants**. Danger flags **Alert** officers to Dangers or special conditions. System also maintains **Cash Transactions** for all fees and costs. System maintains full **Person History** in the Police Central Jacket to aid location and service efforts.

Civil Papers

Maintains a **complete registry** of all Civil Papers types, including issuing jurisdiction, dates, Complainant and Defendant(s). Builds a **List** of multiple Defendants, including multiple addresses, and tracks service attempts, mileage and separate services. **Filing fees**, Person Served, date/time, type of service, and deputy are all tracked in this comprehensive module. **Drop-Down List** is customized for your Courts, Civil Papers Type, and Type of Service. Supplemental Information also customized to local needs.
