

Criminal Warrants Module

3 Outstanding

The Police Central Warrants Module is a complete system for creating Criminal Warrants, and tracking warrant service and history. The Module is **completely integrated** with the Police Central other Police Central Modules, alerting the officer of **prior arrests**, **outstanding warrants** and **dangers**. Contains a Biographical Section, and Warrant Information Section. When Warrant is served, all information is maintained for **criminal history** purposes. Most current historical biographical information is automatically brought forward for new warrants. Fully searchable, and complete reporting. **Photographs** of the subject from prior bookings or outside sources can easily be attached for positive identification! Complete reports of **Warrant** activity.

Biographical Information Section

The Biographical Section of the Criminal Warrants Module captures all relevant personal information, including name, Physical and Mailing addresses, aliases, NCIC compliant height, weight, hair, eyes, etc. Prominent **“OUTSTANDING”** flag indicates warrant status and number of warrants. **“JUVENILE”** flag quickly indicates age of the subject. Most current bio information retrieved when new warrants are added. By entering basic bio information, Police Central automatically retrieves any **history**. Integrated into Police Central Jackets making updates quick and easy.

Warrant Sections

Details of the Warrant Transaction are entered in this section. **Charges** are contained in a **Drop-Down List** of state and local charges. Agency information, prosecutor and bond information can also be captured. Outstanding, Dismissed, Expired and other **Warrant Status** entered by convenient Drop-Down List. Maintains Court, Issue Date, Service Date are maintained by the system. After all information is entered, the Criminal Warrants Module can print the physical warrant, including the photograph -- ready for signature. **Service Attempt** history and **Comments** show history of activity.
